

## 2017 Mid Council Financial Network Conference

You are cordially invited to attend the 2017 Mid Council Financial Network Conference, which will be held in Long Beach, California, at the Hotel Maya.

The conference will begin with breakfast on Wednesday, November 15, and conclude on Friday, November 17, adjourning around noon.

This event is a continuing education and training opportunity for church financial persons, and staff or volunteers working with finances in the presbyteries and synods. Representatives from Presbyterian Mission, Office of the General Assembly, Presbyterian Foundation, Board of Pensions, Presbyterian Investment and Loan Program, Texas Presbyterian Foundation, denominationally endorsed insurance programs, and other key vendors will be on hand. Keynote speaker will be Rev. Denise Anderson, Co-Moderator of the 222<sup>nd</sup> General Assembly. Plenary speaker will be Cory Halliburton, an authority on church law and tax from the law firm WKPZ.

The special dinner event will be held Thursday night aboard the historic Queen Mary with entertainment provided by the Tailor Made Jazz Ensemble featuring Reggie Goodjoin and friends.



## General Information

The registration fee this year is \$285.00 and covers all meeting expenses including administrative costs, meeting rooms, catering, and entertainment during the special dinner event. This fee does not include travel and hotel accommodations.
