## Grant Description

We live in a time of great change, both in church and culture. It is a time rich with opportunity to reach people for Jesus Christ and it is critical that we build the church's capacity to respond faithfully, without the fear of failure. Congregations, presbyteries and faith-based organizations are encouraged to dream and explore new and innovative possibilities for ministry and mission.

College and university campuses are a part of the larger neighborhood in which many of our congregations exist. They are filled with faculty, staff and students — often primarily young adults! How do we reach out to them — both those who have a church affiliation *back home*, and those who have never known church? We believe that congregations are called to a special role in making those connections for ministry, whether that role is to provide fellowship, meals, study, worship or a safe space away from campus. Each congregation must consider its own gifts and the needs of the campus to discover its potential role with and for that community. This one-time grant will assist a congregation seeking to develop a new, ongoing campus connection.

Based on budget and need, grants of up to \$5,000 may be awarded to the applicant.

## ***Synod of the Trinity: Marks of Covenantal Campus Ministry***

Campus Ministry provides a unique opportunity for young adults to develop spiritually, intellectually, and morally as in covenant community they consider and struggle with questions of faith and life.

Recognizing and encouraging the diverse ways in which ministry occurs on different campuses and in different geographic regions, the Synod of the Trinity focuses its support on ministries that are:

- a) reflective of the Reformed tradition,
- b) connected to the larger church,
- c) sensitive to the age-appropriate needs and issues of college students, and
- d) safe environments for faith development.

The Synod will be attentive to the presence of the following characteristics of campus ministry in new and continuing ministries:

### **1. Worship**

Campus Ministry provides opportunities for students to worship together and with the larger church.

### **2. Service**

Campus Ministry connects students with opportunities on the international, national, local, and campus levels to embody the servanthood of Jesus.

### **3. Community & Fellowship**

Campus Ministry facilitates community among students, so that they might build solid, healthy relationships where they learn to live out the commandment to love God and neighbor while recognizing themselves as beloved children of God.

### **4. Discipleship**

Campus Ministry helps students grow as followers of Jesus, as they learn to discern, embrace and employ their gifts, integrating their faith and thus participating in God's work in the world.

### **5. Leadership**

Campus Ministry gives students the opportunity to have active roles in the formation, practice, and evaluation of the ministry

### **6. Congregationally Connected**

Campus Ministry builds relationships between students and local congregations, encouraging both the campus and the congregation to identify ways to grow together in ministry.

## Campus Ministry: Why?

Each time we pour the baptismal waters, we make a covenant to nurture the faith of the newly baptized. Campus ministry provides a valuable resource to the church as we live out that covenant with college aged students.

The promises congregations make in the sacrament of baptism are vital to discipleship. We promise, on behalf of the whole Christian Church, to guide and nurture those being baptized by word and deed, with love and prayer, encouraging them to know and follow Christ Jesus as faithful members of Christ's church. But congregations often struggle with how best to live out these promises with respect to college students, who are learning to think critically, exploring the assumptions of their lives, often in locations far away from the churches of their childhood.

Campus ministry serves the larger church in fulfilling these baptismal promises. It offers an opportunity for college students to explore their evolving selves and to share their experiences with others who also are asking questions of faith. It provides a Christian presence and voice that walks with students as they ask questions of faith – as they express doubt – as they embrace science and critical thinking – as they mature into the people God created them to be. Campus ministry mentors and empowers college students to claim faith for themselves as they experience and navigate the transitions that college brings. Through worship, service and fellowship, it shapes disciples of Jesus Christ and encourages students to become leaders on campus, in the church, and in the world.

At a time when church participation among people of all ages is declining and many young people are leaving the church, campus ministry provides a welcome opportunity to engage college students in the life of faith and in Christian community. By offering a Christian presence on campus, and by encouraging local congregations to connect with college students, campus ministry serves the larger church in living into the baptismal promises made to college youth.

Just as Christ meets people where they are, just as they are, so too campus ministry meets students where they are and walks with them as they grow in life and faith, exploring and sharing their evolving selves and their maturing experience of themselves, others, God, and the world in the context of Christian community.

The ministry and outreach opportunities presented by campus ministry are vital to the future of the church and deserve the wholehearted support of the Synod of the Trinity.
